<u>John</u>-Graduation strategies & Raising Achievement: Asked Opsrey visitors about their average 4 year graduation rate. VES has 65% graduation rate. Testing scores went up. What, specifically, is the school working on now as an initiative? Ryan: working on a one-year graduation goal. At this point there are 11 students who can complete their senior year within one academic year.

Wants to hold parent meetings at Red Lake because a majority of our students come from Red Lake. Jess says that Kwe is working on establishing connections there.

<u>Jess</u>-Director Evaluation Rubric is lengthy and includes points/Google form survey. The reports were summarized and Jess shared with Ryan. Highest score was in vision/culture. Goals are being achieved. Next we should revisit board goals and adjust every few meetings.

<u>Jess:</u> Scholarship Committee is waiting for advice from the school accountant about how to share funds for recent graduates. Focus on on-time graduates. We had a quilt raffle last year. Might need to set up a capital campaign with local businesses. Scholarships not dependent on post-secondary education.

<u>Jess:</u> There are annual Charter School Assurances that the school board should verify and Ryan/Jess should sign. This includes classroom materials, student ability to fulfill their religion, food service, staff hiring, attendance lottery, etc.

5:19 PM Jess: Annual Board Goals. Create a procedure to implement student choice in advisory. This was not attempted yet due to high school staff turnover. What would the guidelines look like? Can the board create a new board attendance policy to include more flexibility? Kari and Kathy say no. This is the law.

John says 100% graduation should be the #1 goal of the school board. Jess motions to approve the goals with edits. Should the list be tabled for next time? Kari would like to postpone and continue the conversation.
